# MYCOXOL-33K

Consortium

Mycorrhiza BioFertilizer

**MYCOXOL-33K** is having spores of consortium of *Rhizophagus irregularis*, *Rhizophagus clarus* and *Funneliformis mosseae*, endomycorrhizal biofertilizer, having symbiotic association with roots of plants. *R. irregularis* has been produced aseptically using Root Organ Culture (ROC) Technology ensuring absence of secondary contamination and consistent spore quality.

### Method of usage

The product can be used directly or as an ingredient for other formulations

### Method of application, when used directly

- In furrow application through fertigation or soil injection @ 0.7-1.0 oz/ha
- Seed coating @ 0.7-1.0 oz/ha
- Soil reclamation after mixing with organic manures @ 1.0-1.5 oz/ha

### Direction of use

- Product should be used during early vegetative growth stage of crop.
- Do not apply along with fungicide. Apply at an interval of 2-3 weeks.
- Always store product in cool dry place, away from direct sunlight

### STORAGE AND DISPOSAL

Store in cool and dry place, away from direct sunlight at ambient temperature. Use the entire content in single application. Keep out of reach of children, pets and farm animals. Disposal should be in accordance with local, state and federal regulations.

### PRECAUTIONARY STATEMENTS

Avoid contact with eyes, skin and clothing. Avoid breathing dust. In case of contact with skin rinse thoroughly with water. Never wash contaminated clothes along with regular laundry. Wear protective apron, gloves and masks while spraying. Wash hands thoroughly after handling. Use adequate ventilation during handling of product.
