DIRECTIONS OF USE AGROBOOST Zn

- Shake the bottle well before making tank mix for spraying.
- Add the recommended volume for preparing the spraying mix.
- AGROBOOST Zn is compatible with almost all leading agrochemicals A "Jar Test" is recommended before mixing and application.
- Use enough volume of water for spraying to ensure full coverage of canopy.
- Apply uniformly on upper and lower plant foliage.
- Do not store the diluted solution for more than 6 hours.
- Avoid spraying on windy and rainy days.
- Spraying should be done preferably in early hours or morning or late afternoon.
- Keep product and all equipment's required away from reach of children and pets.

APPLICATION RATE

Use 10-15 fl oz of AGROBOOST Zn /acre/application. AGROBOOST Zn must be applied at an interval of 3 weeks during early vegetative stage . Total of 1-2 applications are recommended .
